

Ladinar: Submission guidelines for authors

Manuscripts should be written in either British or American English and this choice must remain consistent; if English is not your mother tongue, it is advisable to have your text checked by a native speaker before submission.

The manuscript should be submitted as an electronic file to the address given below in two different formats, Word and PDF, and must not include any reference to the author's name or identity. The author's name, e-mail address, affiliation, and telephone number should be sent in a separate file.

The length of the manuscript should not exceed 25 pages, including references. Use Times New Roman, font size 12, double spacing (including footnotes), and at least 2.5cm margins on each side. Foreign words and phrases must be italicized and explained in English (e.g., *mozos* 'we'). Please refrain from using FULL CAPS (except for focal stress and abbreviations) and <u>underlining</u> (except for highlighting within examples, as an alternative to boldface). Examples should be numbered consecutively throughout the paper. Chapters within the article should be divided into logical sections and, if necessary, subsections. New paragraphs must be indented.

References should be listed at the end of the manuscript as follows:

References in the text: These should be as precise as possible, giving page references where appropriate; for example (Armistead & Silverman 1971: 20-25) or: as in Benabu (1985). All references given in the text should appear in the references section.

All papers will be sent for evaluation. When a paper has been reviewed and corrected according to the appraisers' comments, the author should submit a letter explaining the changes made along with the modified version and a Hebrew Abstract of 300 words, both of which must include the title and the author's name.

Following these guidelines will speed and facilitate acceptance of the paper.
